That the matters and things concerning and connected with as Well as relative to making such amendment will be taken up, considered and voted upon by the members of said corporation to be held at the church of said corporation, situated at the corner of Sixth and Jefferson streets in the City of Moscow, Idaho, the 5th day of  $J_{\rm u}$ ly, 1955, at the hour of 8 c'clock P.M. of said last mentioned date.

That it is proposed to amend article four of its Articles of Incorporation so that the same shall read and be as follows: The Corporation is to have perpetual existence.
