ARTICLES OF INCORPORATION

OF

MOSS FARMS INCORPORATED

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, all citizens of the United States of 6 America, each being over the age of 18 years, do hereby associate 7 ourselves together for the purpose of forming a corporation under 8 and pursuant to the provisions of the laws of the State of Idaho, 9 for the purposes expressed in the following Articles, and do 10 hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME OF CORPORATION: The name of the 12 Corporation shall be: Moss Farms Incorporated.

ARTICLE 2: PURPOSES: The Corporation is organized 14 for the purpose of the transaction of any or all lawful business 15 for which Corporations may be incorporated under the Idaho Business 16 Corporation Act.

TERM: The Corporation is to have perpetual ARTICLE 3: 18 existence.

ARTICLE 4: REGISTERED OFFICE & REGISTERED AGENT: 20 registered office of the corporation shall be located at 300 East 21 450 South, Burley, Idaho, and which has a post office address of 22 Rt. #1 Box 105 Declo, Idaho 83323. The Board of Directors may from time to time fix the consideration for which such shares shall be issued and sold, provided they may not be issued or sold at a value less than par. The capital stock when fully paid, shall be nonassessable, shall be one class of which all shall be voting. Voting of the stock shall be cumulative.

la majority of the shares of capital stock of such other corporation 2 is owned by the corporation, and no act of the corporation shall 3 be in any way affected or invalidated by the fact that any of 4 the directors of the corporation are pecuniarily or otherwise 5 interested in or are directors or officers of such other corpora-6 tion. Any director individually may be a party to or may be 7 pecuniarily or otherwise interested in a contract or transaction 8 of the corporation and any directors of the corporation who are 9 so interested may be counted in determining the existence of a 10 quorum at any meeting of the Board of Directors of the Corporation 11 which shall authorize such contract or transaction and may vote 12 thereon to authorize such contract or transaction with the same 13 right, force and effect as if he were not such director or officer 14 of such corporation and not so interested therein. The same shall 15 apply if any officer or director of this corporation shall be 16 interested in any other form of business entity dealing with this 17 corporation.
