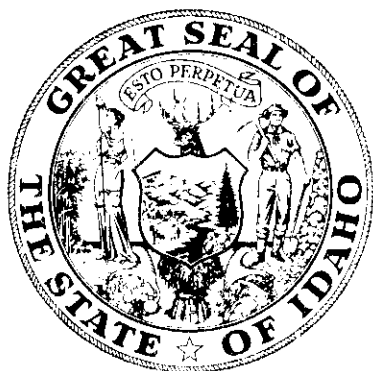

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
OF
NEW FIRST BANK & TRUST OF IDAHO

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act and Section 26-204 of the Idaho Bank Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is New First Bank & Trust of Idaho.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on November 30, 1982, in the manner prescribed by the Idaho Business Corporation Act and the Idaho Bank Act:

Article I previously read "the name of this corporation shall be New First Bank & Trust of Idaho." That Article was amended to read:

The name of this corporation shall be First Bank & Trust of Idaho.

THIRD: The number of shares outstanding at the time of such adoption was 5,750 shares; and the number of shares entitled to vote thereon was 5,750 shares.

FOURTH: The number of shares voted for such amendment was 5,750 shares, there being no shares which voted against such amendment.

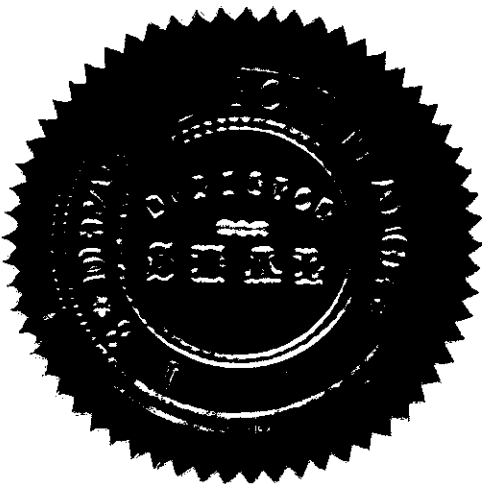
