ARTICLES OF INCORPORATION

L & W, INC. 1007 21 11 9 45

The undersigned acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of this corporation is: L & W, Inc.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose of the corporation is to transact the business of marketing Henry-Griffitts Precision Fit golf clubs and products and all other businesses not forbidden by law.

ARTICLE IV.

The corporation shall have the authority to issue 500 shares of stock, all of one class, no par value.

ARTICLES OF INCORPORATION 1.

ARTICLE V.
