The undersigned, acting as incorporators of a comprofit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Basketball Congress of Idaho, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are for the transaction of any and all lawful business for which nonprofit corporations may be incorporated under the Idaho Non-Profit Corporation Act, which may include, without being limited to, the following purposes: charitable, benevolent, patriotic, civic, educational, social, fraternal and athletic.
