To Whom It May Concern,

University of Colorado Hospital Authority ("UCHA") is a body corporate and political subdivision of the State of Colorado. It was statutorily created in 1991, in sections 23-21-501 through 23-21-604 of the Colorado Revised Statutes. UCHA is not an agency of state government and its mission is to operate the hospital as a teaching and research hospital. UCHA is not registered with the Colorado Secretary of State's office and does not have a certificate of existence on file with the Colorado Secretary of State's office.

UCHA is registered and does business as University of Colorado Hospital Authority. It is not registered nor does it do business as a limited liability company, a partnership, or any other type of corporate structure. The corporate structure of UCHA is a body corporate and political subdivision and it is most akin to a non-profit company. As such, we shall be known in Idaho as University of Colorado Hospital Authority, a non-profit company.
