



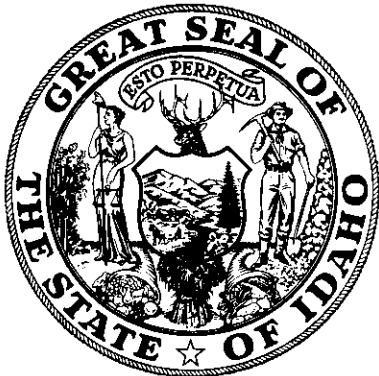
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
REDBIRD RANCH, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Actm adopt the following articles of incorporation:

ARTICLE ONE. The name of the corporation is REDBIRD RANCH, INC.

ARTICLE TWO. The purposes of the corporation are to organize and maintain riding, training and breeding facilities of horses and to conduct a general farm and ranch operation and to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. The period of duration of the corporation is perpetual.

ARTICLE FOUR. The address of the corporation's initial registered office in the State of Idaho is ^{Redbird Road,} P. O. Box 1226, City of Lewiston, County of Nez Perce, 83501. The name of the corporation's initial registered agent at such address is E. B. PONACK.

ARTICLE FIVE. The total authorized number of par value shares of stock is 10,000. The aggregate par value of the total authorized number of par value shares is One Hundred Thousand Dollars, (\$100,000). There is no authorization for shares issued without par value.

ARTICLE SIX. The number if directors constituting the initial board of directors is three (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:
