NAME: The Name of this Corporation is:

TITAN SECURITY OF IDAHO INC.

DURATION: The period of its duration shall be perpetual.

PURPOSE: Its purpose is to engage in all lawful business for which corporations may be incorporated in this state, other states, District of Colombia, territories and colonies of the United States and in foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and convey real and personal property situated out of this state, and particularly to buy, sell, install, maintain and monitor specialized electronic equipment and systems.

CAPITAL STOCK: The Corporation shall have the authority to issue 100,000 shares of common stock in the aggregate. All such shares shall be of one class only and are without par value.

RESTRICTION ON TRANSFERABILITY OF STOCK: The holders of the stock of this Corporation shall be entitled to sell their shares of stock on the open market subject to the following conditions:

FIRST: The stock must first be offered to the Corporation at a price not exceeding the fair value of the stock;

SECOND: If the Corporation does not purchase the stock, the stock must be offered to the remaining shareholders at a price not exceeding the fair value of the stock:

THIRD: The Corporation has the right to redeem the stock of a deceased shareholder at a price not exceeding the fair value of the stock at the end of the month preceding the month in which the shareholder died;

FOURTH: If the Corporation does not redeem the stock of a deceased shareholder, the remaining shareholders shall have the right to purchase the stock at a price not exceeding the fair value of the stock at the end of the month preceding the month in which the shareholder died.

INDEMNIFICATION OF DIRECTORS AND OFFICERS: Every director and officer of this Corporation shall be indemnified against

all liabilities, civil and criminal, incurred in relation to his duties, including all reasonable expenses of defense, except to the extent that he shall have been finally adjudged to be liable for negligence or misconduct in the matters out of which the liability arises.

LIMITED LIABILITY: The private property of the shareholders shall not be subject to assessment for the purpose of paying expenses, conducting the business or paying the debts of this Corporation.

SHARES NONASSESSABLE: The shares of this Corporation shall not be subject to assessment for the purpose of paying expenses, conducting the business or paying the debts of this Corporation.
