The Hon. Board of County Commissioners meet this day pursuant to adjournment of yesterday, there being present T.J. Stephenson, Chairman, Norval Corrie and C.A. Campbell, Commissioners, and I, F. Smith, Clerk, the following proceedings are had, to-wit:

Whereas a petition filed April 11th. 1902, containing the names of a majority of the taxable inhabitants of the Village of Cambridge (as shown by a duly verified census taken and filed, and the assessment book for the year 1901 of this County) praying that they may be incorporated as a village, the same to be named Cambridge and describing the metes and bounds thereof, and it appearing to the satisfaction of this Board that more than a majority of the taxable inhabitants of said proposed village have signed said petition, and it further appearing to the Board by the return of said Census that said proposed village contains more than two hundred and less than one thousand inhabitants and that inhabitants to the number of two hundred or more are actual residents of the territory described in the said petition.

Now Therefore, it is hereby ordered by a unanimous vote of this Board that the said petition is granted and that the said village is hereby incorporated under and by virtue of Sec. 40 of an Act of the Legislature of the State of Idaho entitled "An Act to provide for the Organization, Government, and Powers of Cities and Villages" Approved on the 10th day of February 1890, and is named "Cambridge" bounded and described as follows, to-wit:

The West half of the South West quarter of Section Two, the East half of the South East quarter of Section Three, the North East quarter of the North East quarter of Section Ten and the West half of the North West quarter of the North West quarter of the North West quarter of Section Eleven all in Township Fourteen North of Range Three West of the Boise Meridian in Washington County, Idaho, and H.R. Neal, H.H. Hopper, W.H. Eckles, D.J. Butcher and J.I. Lorton are hereby appointed as Trustees of said village of Cambridge.

In the Matter of the

For an appropriation for the construction of a Public highway from Council, Washington County, Idaho, to Long Valley in the County of Boise, State of Idaho,

It is hereby Ordered that the sum of Four Hundred Dollars be appropriated towards the payment of the expenses of constructing a public highway from the Town of Council, in the County of Washington, State of Idaho, to a point in Long Valley, to be determined by the persons hereinafter named, that the payment of the said sum of Four Hundred Dollars shall be contingent on the completion of the said road to Long Valley and the proper expenditure of said appropriation shall be certified to by S. Haworth, Isaac McMahan and C.A. Campbell.
