ARTICLES OF INCORPORATION

OF

KAHIAH GRAIN, THE.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States of America, all of legal age, and residents of the state of Idaho, do hereby associate curselves together to form a corporation, and in order to form a corporation for the purposes hereinafter stated under the provisions of the General Business Corporations laws of the State of Idaho, do hereby CERTIFY AND DEMIARE as follows:

ĺ.

The name of this corporation is, MARIAH GRAIN, 140.

II.

The objects and purposes for which this corporation is formed are as follows;

A. To engage in the bauling of all types of goods and commodities from one point to another. Also, to accept from and deliver to other shippers, trucking firms, railways, sirlines, or water carriers, both public and private; all types of commodities, to store the same, to feed and care for any livestock involved. Also, to have one or more officers or places of business, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and convey real and personal property situated in or out of this state. Also, to construct, purchase, contract, lease, or otherwise acquire, maintain and operate recreational facilities, wholesale and retail morehandising and service business or any other legal businesses, as authorized by the laws of the Diate of Idaho and the United States of America, including any and all legal egricultural facilities. Also to purchase, lease or otherwise acquire land for the purposes of erecting office buildings, plants, work-shops, dwelling houses, warehouses, stores, hobels, motels and other buildings in connection with the foregoing purposes.

- F. To invest in, take over, buy, sell, pledge and exchange stock, shares, bonds, and other securities of any company whether incorporated under the laws of the several commonwealths of under the laws of any foreign company or country. To make advances apon, hold in trust, buy and sell on cormission, and sell or dispose of any investment aforesaid, or to act as auditor for any of the above or like purposes. To hold, purchase, or otherwise acquire, to sell, assign, transier, mortgage, pledge on margin, or otherwise dispose of shares of the capital stock, bonds or securities issued or created by any corporation, and while the holder thereof, to exercise all the rights and privileges of ownership including the right to vote thereof. To cause or allow the legal title, estate and interest in any property acquired, established or carried on by the company to remain or to be vested or registered in the name of or carried by the company or any other companies, foreign or domestic, formed or to be formed, and either upon trust for or as agent, or nominee of this company, or upon other terms of conditions which the Board of Directors may consider for the benefit of this company, and to manage the affairs or take over and carry on the business, of such company or companies, so formed, either by acquiring the shares, bonds or other securities thereof, or otherwise howsoever, or to exercise any or all of the powers of the holders of shares, bonds or securities thereof, and to receive and distribute as profits or dividends any interest on such shares, bonds or other securities. To guarantee the payment or dividends or interest on any shares, debentures or other securities, issued by, or any other contracts or obligations of any corporation, when in the judgment of directors the same is proper or necessary for the business of the company, provided the acquired authority be first obtained from the Board of Directors for that purpose.
- G. To renumerate any person or persons or corporations for the services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any shares of the companies capital stock or any debentures

or securities thereof, or in or about the formation or promotion of the company or the conduct of its business as deemed proper.

This Corporation is formed to have perpetual existance from the date of its incorporation.

IV.

The principal place of business and its registered offices are and is Kamiah, Lewis County, State of Idaho.

V.

The number of directors of this corporation shall be three (3) but such number may, from time to time, be increased or decreased in such manner as may be provided in the By-laws. In case of an increase in the number of directors, the additional directors may be elected by the directors then in office, and as such director or directors so elected they shall hold office until the next annual meeting of members, and until their successors are elected and qualified. The first board of directors of this corporation shall be as follows: T. E. Robinson, Eamiah, Idaho; Orville H. Martin, Memiah, Idaho; and Linda R. Martin, Kamiah, Idaho.

The capital stock of this corporation shall be in the total sum of \$10,000.00 and shall be divided as follows:

The voting stock of this corporation is the common stock and no other stock shall have any voting rights in this corporation. The Corpor Stock shall participate in the distribution of profits as set forth in the By-Laws of this Corporation. The Corporation may purchase and own shares of its own Gommon Stock and hold the same as treasury stock.

The corporation shall be governed by a duly adopted code of by-laws, which by-laws shall not be inconsistent with the provisions of these Articles of Incorporation, nor inconsistent with the corporation agreement of the parties, nor inconsistent with the laws of the State of Idaho; a meeting of the corporation shall be held and the said by-laws shall be adopted in accordance with the provisions of the laws of the State of Idaho after the issuance by the Secretary of the said State of Idaho of the Certificate of the corporation.

These Articles of Incorporation may be amended by a majority vote of the stock issued at any regular meeting or at a special meeting called for that purpose by a majority of the Baord of Directors after thirty (30) days notice to all belders of stock, which notice shall be in conformance with the statutes of the State of Idaho made and provided therefore.
