ARTICLES OF INCORPORATIONE 19 3 07 PH '80

SECRETARY OF STATE CAVENDISH UNITED METHODIST CHURCH, Significated

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of the laws of the State of Idaho, for the purposes expressed in ARTICLE II hereof, do hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be CAVENDISH UNITED METHODIST CHURCH, INCORPORATED.

ARTICLE II.

The objects of this corporation are:

- The corporation shall support the doctrine, and it, and all of its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of the United Methodist Church as the same are or shall be from time to time established, made and declared by the lawful authority of the said church.
- The corporation shall have the power to acquire В. and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, encumber, lease, sell, convey and dispose of all such property in conformity with the Dicipline of the United Methodist Church. The corporation shall have the further right to borrow money by any lawful means to carry out the objects of the corporation, encumbering its properties as security therefore, all in conformity to said dicipline.
- Subject to the provisions of the Dicipline, the corporation shall have the power to erect and maintain all

buildings for the worship of God, for training in Christian faith and conduct and for christian social intercourse, and to acquire or build and maintain residences for the use and occupancy of its ministers.

- D. To beautify and improve the property of the said corporation by the construction of playgrounds, landscaping, parking facilities, and other improvements in conformity with the general purposes of the organization and the welfare of its members and community.
- E. To engage in all forms of religious, missionary, social and charitable work or endeavor, and in general promote, spread and establish the christian gospel, and to furnish and provide training and instruction for the youth of the community.
- F. Any other lawful purpose in keeping with the nature of this corporation.

ARTICLE III.

The duration of this corporation shall be perpetual.

ARTICLE IV.

This corporation shall be a non-profit organization and its membership shall be the membership of the Charge conference of the CAVENDISH UNITED METHODIST CHURCH established by the Pacific Northwest Annual Conference of the United Methodist Church as procided in the Discipline of the United Methodist Church.

ARTICLE V.

The location of the corporation's registered office will be at

ARTICLE VI.

The names and post office addresses of the first directors are as follows:

The above named directors are to hold office until his successor shall have been elected and qualified, or until he shall die, resign, or shall have been removed.

ARTICLE VII

The Board of Directors of the corporation shall be the Board of Trustees of the above mentioned Conference Charge, elected and organized as prescribed in the Discipline of The United Methodist Church.

ARTICLE VIII.

The authority to make By-laws for this corporation is expressly vested in the Board of Trustees, subject to the power of the members to change or repeal such By-laws. Such By-laws of the corporation shall be in conformity with the laws of the State of Idaho, and shall include the Discipline of the United Methodist Church as from time to time enacted, authorized and declared by the general conference and no other By-laws shall be adopted inconsistent with the provisions of the Discipline.

ARTICLE IX.

If, for any reason, at any time this corporation shall cease to exist as a legal entity and its charter shall espire or be terminated, then the title to all its property

both real and personal, shall be vested in the Board of Trustees of the Pacific Northwest Annual Conference of the United Methodist Church, a corporation; and all such property shall be held in trust for the benefit of the above mentioned local church.
