

ARTICLES OF AMENDMENT
OF
PARK & BYERS TOWER, INC.

The undersigned, being the President and Secretary of the corporation whose Articles of Incorporation were duly amended in accordance with Idaho Code 30-326, execute the following (Articles of Amendment):

PREFACE: Article I of the original Articles of Incorporation is hereby amended to read and shall hereafter constitute Article I of Articles of Incorporation of the corporation as follows:

ARTICLE I. NAME


The name of this corporation (hereinafter called the "Association") shall be COEUR D'ALENE NORTH HOMEOWNERS ASSOCIATION, INC.

No other provision of the Articles of Incorporation are amended.

That the date of the adoption of this amendment was August 19, 1986.

That the date of the meeting of the members was held on the 19th day of August, 1986 at which the amendment was adopted, that a quorum was present at such meeting and that the amendment received at least a majority of votes cast which members present at such meeting were entitled to cast.
