The undersigned, in order to form a Corporation under the provisions of Title 30, Chapter 1, Idaho Code, submits the following articles of incorporation to the Secretary of State.

**Article I**

**NAME:** The name of the corporation shall be PROBES, Inc.

**Article II**

**PURPOSE AND POWERS:** The purpose and powers for which this corporation is formed are (1) to engage in "projects for research on biological and environmental subjects"(PROBES); (2) to have all rights and powers normally ascribed to and incidental to said primary purpose and to business operations in general including, but not limited to raising capital and operating monies; entering into, performing and carrying out contracts; entering into joint ventures or limited partnerships; acquiring, by purchase or otherwise, maintaining, developing, improving, financing, mortgaging, selling, renting, or exchanging such real property, equipment and other facilities as are needed by the Corporation, and to undertake all business transactions, functions and services ordinary and necessary to the business, as set forth above; and (3) to engage in any other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**Article III**

**DURATION:** Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

**Article IV**

**REGISTERED OFFICE:** The address of the initial registered office of this corporation in the state of Idaho shall be 80 Kirk Drive, Boise, Idaho 83716-3264, and the name of the initial registered agent at that address shall be Donald R. Brothers.

**Article V**

**CORPORATE STOCK:** The aggregate number of shares which this corporation shall have authority to issue shall be one hundred thousand (100,000) shares of nonassessable, common stock having a par value of \$0.01 per share.
