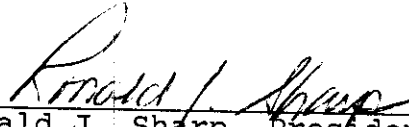
CERTIFICATE OF CORPORATE RESOLUTION

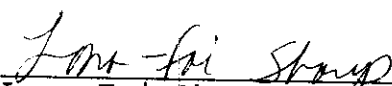
