Article 2: The purpose for which the corporation is organized is:

The Friends of Sweet Hollow Equine Park has been Organized to (1) promote the education of children under the age of 18 in various equine sports, including but not limited to: all rodeo events( barrel racing, pole bending, roping), jumping, dressage, training, proper care, and the interaction with large domestic animals, specifically horses.(2)Provide a place for existing youth organizations, related to large domestic animals, a place to meet and work year round.(3)Develop education programs for the mentally, emotionally, and physically challenged. We envision these programs will be available as guides for similar programs in sister communities.

The specific purposes of the Corporation are to construct an indoor riding arena on property of the City of Victor, or such other property that may become available, and to operate and maintain this facility. To that end, the activities of the Corporation shall include, but not be limited to, the following:

- a. Obtaining grants and contributions to fund the design and construction of an indoor riding arena, and to raise funds to provide for the operation and maintenance of this facility.
- b. Assisting and coordination equine related groups throughout the Teton Valley of Idaho and Wyoming in the conduct, education, and promotion of their activities.

The Corporation is a public benefit corporation. The purpose for which the Corporation are formed are for educational and charitable purposes within the meaning of Para501(c)(3) and Para 509(a)(1) of the Internal Revenue Code of 1954 ( references in these Articles to particular provisions of the Internal Revenue Code of 1954 shall be deemed to include the corresponding provisions of any future United States Internal Revenue Law).

The Corporation is organized and shall be operated in the public interest and is constituted so as to attract substantial support from governmental organizations and public contributions, whether directly or indirectly, and is not organized and shall not be operated for pecuniary profit or financial gain; and no part of the assets, income or profit of the Corporation is distributable to or inure to the benefit of, its trustees or any private individual.

Article 8: Upon dissolution the assets shall be distributed:

To the city of Victor for the operation and maintenance of the facility for the public purpose. However, if the named recipient is not then in existence or no longer a qualified distribute or unwilling or unable to accept the distribution, Then the assets of the corporation/ organization shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.
