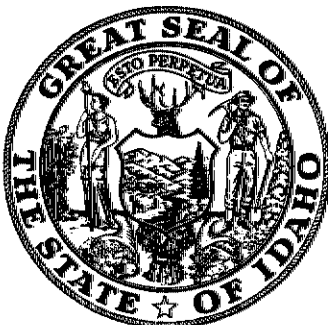

ARTICLES OF AMENDMENT
OF

SANDPOINT MORTGAGE CORPORATION

PURSUANT TO Sections 30-1-58 and 30-1-59 of the Idaho Code, SANDPOINT MORTGAGE CORPORATION, an Idaho corporation, adopts the following articles of amendment to its Articles of Incorporation filed March 29, 1993.

ARTICLE I. By a unanimous vote of all the shareholders (10,000 shares outstanding) of the corporation at a meeting held in Sandpoint, Idaho, on August 24, 1995, the corporation, by amendment, added the following to ARTICLE II of its Articles of Incorporation:
