Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to it Articles of Incorporation:

FIRST: The name of the corporation is Ada-Boi, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on February 20, 1981, in the manner prescribed by the Idaho Business Corporation Act:

## ARTICLE V.

The amount of the capital stock of the corporation shall be, and is, \$22,500.00, divided into 2,250 shares. Each such share shall have a par value of \$10.00. Said stock shall be, and is, nonassessable. No further capital stock shall be authorized without the permission of all of the outstanding shares of stock.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1500; and the number of shares entitled to vote thereon was 1500.

 $\,$  FOURTH: The number of shares voted for such amendment was 1500; there were no votes against such amendment.

FIFTH: The manner in which such amendment affects a change in the amount of stated capital, and the amount of stated capital as changed by such amendment, are as follows:

The amount of stated capital is increased by \$7,500 by authorizing an additional 750 shares at a par value of \$10.00.
