The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is DONNELLY PROPERTY MANAGEMENT, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to provide rental property care and management and any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
