The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation.

ARTICLE ONE: The name of the corporation is: B & K TRANSPORTATION COMPANY.

ARTICLE TWO: The period of duration of the corporation is perpetual.

ARTICLE THREE: The purpose of the corporation is (1) to conduct a truck transport business, and (2) to engage in any and all lawful business for which a corporation may be organized under the Idaho Business Corporation Act.

ARTICLE FOUR: The total number of authorized shares that the corporation shall have is One Thousand (1,000), which shares shall be without par value.

ARTICLE FIVE: There is no provision for denying preemptive rights to the shareholders.

ARTICLE SIX: There are no provisions for the regulation of the internal affairs of the corporation.

ARTICLE SEVEN: The address of the initial registered office of the corporation is: 4005 North Fifteenth Street, Coeur d'Alene, Idaho. The name of the registered agent is: William Cecil.

ARTICLE EIGHT: The initial board of directors has two directors. The names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

ARTICLE NINE: The name and address of the incorporator are: William Cecil, P. O. Box 4704, Coeur d'Alene, Idaho 83814.

ARTICLE TEN: The directors of the corporation shall not be personally liable to the corporation or to any of its shareholders for monetary damages for a breach of fiduciary duty as a director except for breach of duty of loyalty to the corporation or stockholders, acts or omission not in good faith or intentional misconduct, and transactions from which the director derived an improper personal benefit.
