1. The name of the corporation is T & B Industries, Inc.
2. Its duration is perpetual.
3. Its purpose is to transact the business of providing labor to construct bale stacking and retrieving apparatus and other agricultural equipment. In addition thereto, to do research and development on agricultural equipment, custom farming, own and operate agriculture equipment for custom farming operation and all other business not forbidden by law.


