The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, verifying that, pursuant to Idaho Code Section 30-1-1002, no stock in the company has been yet issued, therefore adopts the following Amended and Restated Articles of Incorporation of such corporation. These Amended and Restated Articles of Incorporation shall in all respects replace and supercede the Articles of Incorporation filed on August 4, 2009, a copy of which is attached as Exhibit "A".

FIRST

The name of the corporation is: **Freeway Tire & Truck Repair, Inc.**

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized: to provide tire and truck repair services as well as to do all acts and exercise all powers, rights and responsibilities available to corporations under the laws of the state of Idaho.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock with no par value. Said stock shall be subject to transfer restrictions of first right of refusal as may be set forth in the By-Laws of the Corporation.


No stock of this corporation shall be pledged, hypothecated, transferred,
