
### CERTIFICATE OF INCORPORATION OF

STATE OF IDAHO

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is Barthlome Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are: For any and all lawful purposes allowed by the Idaho General Business Act, Title 30, Chapter 1, Idaho Code.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1,000, all of one class, \$.10 par value.

**FIFTH:** Provisions denying preemptive rights are: None.

**SIXTH:** Provisions for the regulation of the internal affairs of the corporation are contained in the By Laws of the corporation.
