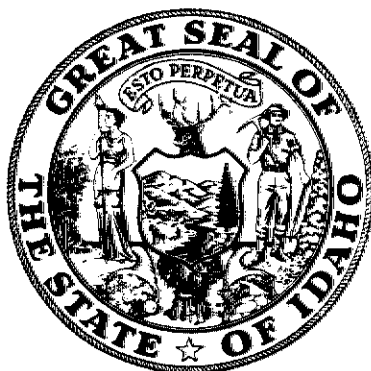

2. The amendment of the articles adopted reads as follows:


"Resolved, that ARTICLE SECOND (k) of this corporation is amended to read in its entirety as follows:
