

JOINT AGREEMENT OF MERGER OF  
BROKEN ARROW FARMS, INC., an Idaho corporation, into  
B & T FARMS, INC., an Idaho corporation

THIS JOINT AGREEMENT, by and between the duly elected and acting Board of Directors of B & T Farms, Inc., an Idaho corporation, the party of the first part herein, and the duly elected and acting Board of Directors of BROKEN ARROW FARMS, INC., an Idaho corporation, the party of the second part herein;

WITNESSETH:

WHEREAS, the parties hereto are both corporations, organized and existing under the laws of the State of Idaho, and do desire to merge, to the effect that the party of the second part is merged into the party of the first part, under the laws of the State of Idaho, made and provided for merger of domestic corporations, effective the 1st day of March, 1971.

The following agreement is signed by all of the members of the Board of Directors of the parties hereto. This agreement is to the effect that after the said merger, only one domestic corporation would be in existence, and that corporation would be B & T Farms, Inc., an Idaho corporation.

The terms of the merger are that for 20.271 shares of the common stock of Broken Arrow Farms, Inc., the stockholders are to receive 1 share of the common stock of B & T Farms, Inc.

It is mandatory that all of the stock of Broken Arrow Farms, Inc., shall be delivered to B & T Farms, Inc., in connection with the merger, and all of the same shall be subject to the rights of any dissenting stockholder, in the manner prescribed by law.

This joint agreement is being presented to the shareholders of each corporation for ratification and vote, in the manner
