And we hereby certify:

First. That the name of said corporation is Valley Market.

Second. That the purposes for which it is formed are to carry on the business of a meat market and grocery store, to buy or raise livestock to butcher and sell the meat from, to buy and sell ready dressed meats and generally to dal all things usually dones in connection with a retail meat market and grocery store.

Third. That the place where it's principal business is to be transacted shall be the Village of Meridian, County of Ada.

Fourth. That the term for which it is to exist is fifty years from and after the date of it's incorporation.
