OPTIONAL ARTICLES

Article 7: Board of Directors. All professional corporate powers shall be exercised by or under the authority of, and the business and affairs of the professional corporation managed under the direction of, its board of directors, subject to any limitation set forth in a shareholder agreement authorized under section 30-1315, Idaho Code.
