

ARTICLES OF INCORPORATION OF THE

Snake River Valley Canal Company.

Know All Men by These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho

And We Hereby Certify,

First: That the name of said Corporation is Snake River Valley Canal Company

Second: That the purposes for which it is formed, are

To make a canal (26) twenty six feet wide at the bottom, banks to have one and one half feet (1-1/2) slope .canal is to be made to irrigate land belonging to the stockholders.the Head of canal shall be at a place where the Cedar Point Companys head is situated ,Head and canal shall be an enlargement of Cedar Point Companys' head and carried to such a distance as practicable which is to be at or near where the Cedar Point Co's ditch crosses the Holbrook ditch. It shall there diverge from Cedar Point Co's Canal and continue in an easterly direction as far as practicable

Third: That the Capital Stock shall be Fifty thousand dollars divided into 5000 shares of Ten dollars each.

Fourth: That the place where its principal business is to be transacted shall be Basalt, Bingham County, Idaho.

Fifth: That the term for which it is to exist is Fifty years from and after the date of its Incorporation.

Sixth: That the number of its Directors or shall be Five and that the names and residences of those who are appointed for the first year are:
