The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be D & H Trade Bindery, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 524 Franklin Park Circle, Boise, Idaho 83707, and the name of the initial registered agent at such address is Gary D. Dotson.

IV.
