ARTICLES OF INCORPORATION  
OF  
EASTERN IDAHO STOCK CAR RACING ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho, and we do hereby certify:

I.

That the name of the corporation shall be EASTERN IDAHO STOCK CAR RACING ASSOCIATION, INC.

II.

That the purposes for which this corporation is formed are:

1. To organize and bring together all persons interested in automobile racing of all types and kinds for the purpose of improving the quality and safety of said hobby and sport and further to exchange information and ideas on the construction and maintenance of racing vehicles and their supporting equipment.
2. That the corporation shall not engage in any business, trade avocation, or profession for gain or profit.
3. To do all things necessary, and essential, convenient, or proper for the accomplishment of any and all of the aforementioned purposes for the attainment of any and all of the objects above mentioned, or incident to the powers herein named, or which shall have at any time appeared to be conducive or expedient or beneficial to the corporation, and to such end to have any and all powers conferred upon non-profit cooperative associations

organized under the statutes of the State of Idaho.

III.

Subject to the dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

IV.

That the principal place of business, registered office and location and Post Office address of the registered office of said corporation shall be in the City of Idaho Falls, 470 Holbrook Drive, Bonneville County, State of Idaho.

V.

That the right and interests of all members of this association shall be equal and no member shall, can have or acquire a greater interest than any other member. That this association shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificate cannot be assigned so that the transferee thereof can by such transfer become a member of the association, except by resolution of the Board of Directors and under such regulations as the By-Laws of this corporation may prescribe.

VI.

That the number of directors of said corporation shall not be less than three (3), nor more than seven (7), to be elected annually.


