Articles of Incorporation
of the
American National Trust Company.

Know All Men by These Presents, that we the undersigned, H. A. Van Valkenburg, Jacob Hoover, J. R. Taylor, J. W. Binkley and J. B. Wood, have voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Washington, and we do hereby certify as follows: -

Article I.

That the name of said Corporation shall be the American National Trust Company.

Article II

That the business and objects of this corporation, and the purposes for which it is formed, are as follows: -

To act as the fiscal or transfer agent of any State, Municipality, body politic, or Corporation, and in such capacity to receive and disburse money, and transfer, register, and countersign Certificates of Stock, Bonds, Debentures, or other obligations or evidences of indebtedness.

To receive trust moneys, securities and other personal property from any person, persons or Corporations.

To lease, purchase, hold and convey any and all real estate necessary in the transaction of its

business, or which the purposes of the Corporation may require, or which it shall acquire in satisfaction, or partial satisfaction, of debts due the Corporation under sales, judgments, mortgages, or in settlement, or partial settlement of debts due the Corporation by any of its debtors, or in payment, or part payment, for its services.

To act as trustee under any mortgage, bond or other obligation issued by any municipality, body politic, or corporation, and accept and execute any other municipal or corporate trust not inconsistent with the law.

To take accept and execute any and all such legal trusts, duties and powers in regard to the holding, management and disposition of any estate, or property real or personal, and the rents, issues and profits thereof, or the sale thereof, as may be granted or confided to it by any Court of Record, or by any person, corporation, municipality or other authority.

To take, accept and execute any and all such trusts and powers of whatsoever nature or description as may be conferred upon, or intrusted or committed to said Corporation by any person, or persons, or any body politic, corporation, or other authority, by grant, assignment, transfer, devise, bequest or otherwise, or which may be intrusted or committed or

transferred to, or vested in said Corporation by order of any Court of Record, and to receive, and take and hold any property or estate, real or personal, which may be the subject of any such trust.

To be appointed and to accept the appointment and perform the duties of, executor or trustee under the last will and testament, or administrator with or without the will annexed, of the estate of any deceased person, and to be appointed, and to act as, the guardian or committee of the estate of minors, lunatics, idiots, persons of unsound mind, and habitual drunkards, and to act as receiver, or trustee, in cases of insolvency or bankruptcy.

To accept trusts from, and execute trusts for, married women in respect to their separate property, whether real or personal, and to be their agent in the management of such property, or to transact any business in relation thereto.

To loan money on real estate or personal security.

To take, hold, purchase, sell, assign, pledge, hypothecate release and otherwise acquire, dispose of and deal in mortgages, and other liens on real estate or personal property and bills, bonds, notes, debentures, stocks, warrants, and securities of all kinds, and other negotiable paper and evidences of debt.

To act as depository of any moneys paid into Court.

To act as surety upon bonds and undertakings given in legal proceedings or otherwise.

To guarantee the safety of any and all investments made by it as trustee or agent, and the payment of rents, interest, or other income arising from the same.

To borrow money for any or all the purposes aforesaid.

To make, execute, issue, sell, transfer and negotiate the bonds, debentures, notes, certificates of deposit and other obligations and evidences of debt of this Corporation.

To do and perform any and all of the acts and things above mentioned and carry on the business aforesaid in the State of Washington, and in any or all of the States and Territories of the United States, and in the Dominion of Canada, and in Europe.

Article VIII.

That the amount of the Capital Stock of said Corporation shall be Five Hundred Thousand (\$500,000) Dollars, and shall be divided into Five Thousand (5,000) shares of the par value of One Hundred (\$100) Dollars each.

Article IX.

That the term for which said Corporation is to exist is Fifty (50) years from and after the date of its incorporation.


Article V.

That the concerns and business of the said Corporation shall be managed and conducted until the twenty first day of January A. D. 1892. by a Board of Five (5) trustees whose names are as follows, to-wit: H. A. Van Valkenburg, Jacob Hoover, J. R. Taylor, J. W. Binkley and J. B. Wood, all residing in the City of Spokane, Spokane County, State of Washington.

Article VI.

That the principal place of business of said Corporation shall be located in the City of Spokane, Spokane County, State of Washington.
