## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PROBIOTICS, INC.

Pursuant to the provisions of the Idaho General Business Corporations Act (Chapter 1, Title 30, Idaho Code), the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation:

- Prior to the adoption of these Amendments, the name of the corporation was PROBIOTICS, INC.
- The following amendment to the Articles of Incorporation was adopted by the shareholders:
- That Article First of the Articles of Incorporation be amended to change the name of the corporation from "PROBIOTICS, INC." to "NUTRI-PLUS, INC.".
- The foregoing amendment to the Articles of Incorporation was adopted at the Special Meeting of the shareholders of the corporation held on the 2nd day of January, 1989, pursuant to due hotice.
