The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1.

The name of this Corporation is: **Idaho Technology Council, Inc.**

Article 2.

The purpose for which the corporation is organized:

- a) To promote the general welfare of the people and stimulate technology and innovation in Idaho related to information technology, agriculture and natural resources, energy, and life sciences.
- b) To align, advocate, and educate individuals and groups regarding
 - a. Growing technology and innovation;
 - b. Making sure we have a well trained, quality workforce focused on science and technology and business operational skills;
 - c. That funding opportunities are provided for growing technology companies, emerging technologies, and intellectual property both public and private;
- c) Connecting members is one of the Idaho Technology Council's primary functions as well as sharing insights with industry peers, government and educational leaders, capital venture firms, and other professional service providers;
- d) To secure united, intelligent and effective action on matters of interest to its members;
- e) To cooperate in a united manner toward the better development of Idaho innovation and beneficial and positive relations between industry, government agencies, education, those that commercialize intellectual property, employers, employees and the public with do regard for the rights and duties of all.

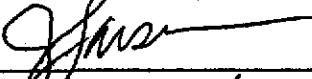

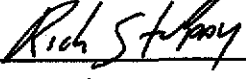
