ARTICLES OF INCORPORATION MAY 10 PM 4 28
FOR THE COMPANY
NORTHWESTERN COMMUNICATIONS INC. SEC. OF STATE

The period of time for which this corporation shall exist shall be perpetual.

The purpose for which this corporation is organized is to provide service to Broadcast and Telecommunications companies. The primary type of service we offer to these businesses is Tower and Antenna installation, maintenance and repair. We shall also sell miscellaneous items in the process of performing our services.

The corporation shall issue one thousand shares of common stock (1,000 shares) with a par value of six (\$6) dollars per share. These shares of stock shall be owned by the three incorporators of the company and one outside investor. The company retains the right to purchase any available shares before they are offered to other parties. The company shall have the option to purchase said shares for a period of sixty (60) days, unless it waives its option prior to the end of this period. The corporate officers shall have the same purchase option available to them, as the company does. The time period runs concurrent to that of the company, however, the officers must await the decision of the company prior to exercising their option. The corporate officers shall exercise their option to purchase in the order of their position in the company.


