#### ARTICLES OF AMENDMENT

OF SEC

LOJEK & PENLAND, CHARTERED

The undersigned, as President and Secretary of Lojek & Penland, Chartered, pursuant to Idaho Code § 30-1-61, do hereby set forth the following Articles of Amendment to the Articles of Incorporation, as follows:

- (a) The name of the corporation is Lojek, Penland & Munther, Chartered.
  - (b) The amendments so adopted are:

 $\underline{\text{ARTICLE I}}$ : That the name of this corporation shall be LOJEK, PENLAND & MUNTHER, CHARTERED.

ARTICLE IV: The corporation shall have the authority to issue 1,000 shares of no par value stock.

- (c) The date of the adoption of the amendment by the shareholders was March 1, 1985.
- (d) The number of shares outstanding is 70, and the number of shares entitled to vote thereon is 70.
- (e) The number of shares voted for such amendments is 70 and the number of shares voted against such amendments is -0-.
- (f) The amendments do not provide for the exchange, reclassification or cancellation of issued shares.
