## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

STUDENT LOAN FUND OF IDAHO MARKETING ASSOCIATION,

Pursuant to provisions of Section 30-326, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

<u>FIRST</u>: The name of the corporation is Student Loan Fund of Idaho Marketing Association, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the corporation on March 13, 1992, in the manner prescribed by Section 30-326, Idaho Code, so as to amend the Articles to read as follows:

Amend Article Four to read as follows:

### ARTICLE FOUR PURPOSES

This Association is established and shall be operated exclusively for the purpose of acquiring student loan notes incurred under the Higher Education Act of 1965. It is not organized for a pecuniary profit. It shall devote any income (after payment of expenses, debt service, and the creation of reserves for the same) to the purchase of additional student loan notes or to pay over any income to the United States Government to the extent required by Section 150(d) of the Internal Revenue Code.

ARTICLES OF AMENDMENT - 1.

#### 2. Amend Article Nine to read as follows:

ARTICLE NINE ELECTION OF DIRECTORS, ETC.

The number, qualifications and term of office of the directors shall be prescribed by the bylaws and the new directors shall be elected by the existing directors pursuant to I.C. § 30-314(f).

THIRD: The above amendments to the Articles of Incorporation were adopted by unanimous vote of all of the members of the corporation and all of the members of the Board of Directors at a special meeting of the members and Board of Directors held pursuant to notice on March 13, 1992.
