### CERTIFICATE OF INCORPORATION

I, JAS H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**COMMUNITY BIBLE CHAPEL INC., OF PAYETTE, IDAHO**

was filed in the office of the Secretary of State on the **3rd** day of **October** A. D. One Thousand Nine Hundred **Fifty-seven** and is duly recorded on Film No. **100** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Payette** in the County of **Payette** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

COMMUNITY BIBLE CHAPEL

ROUTE NO. 2

PAYETTE, IDAHO

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age, and citizens of the United States, having associated ourselves together for the purpose of forming a religious corporation under, and by virtue of the laws of the State of Idaho, do hereby certify as follows:

I

That the name of the corporation is, and shall be, Community Bible Chapel Inc., of Payette, Idaho.

II

The duration of this corporation is from September 1957, and is to have perpetual existence.

III

The location and principal office of this corporation shall be Rural Route No. 2, Payette, County of Payette, Idaho

IV

This corporation shall be holiness interdenominational.

V

The purpose for which said corporation is organized and incorporated is, and shall be:

(1) To establish and maintain a place of Divine worship.

(2) The study, and practice of godliness as set forth in the Sacred Scriptures of the Old and New Testaments.

(3) The exercise of a spiritual watch-care over each other, of those who shall become adherents, and edifying one another in the Christian faith.

(4) To carry out the great commission of our Lord, in preaching and publishing the gospel to the people of its ministry, to be accomplished by establishing and promoting Sunday Schools, missions, and all other means deemed practical.

(5) To purchase, lease, acquire, accept, hold and manage, by deed, grant, will, gift, bequest, trust or otherwise, all manner and kinds of property, whether real, personal or mixed, to be used for, and carry out the purpose for which said corporation was organized.

(6) To borrow, sell, mortgage, issue notes, bonds, debentures and other evidences of indebtedness, and to do any, and every, act or thing, germane to any of the aforesaid purposes.

(7) Pecuniary profit shall not be the object or purpose of this incorporation.

## VI

The estimated value of the property and money possessed by this corporation at the time of executing these articles of incorporation within the State of Idaho and vested in said corporation is One Thousand Two Hundred and Fifty Dollars (\$1,250.00). The sources of revenue or income in this corporation is and will be, pledges, gifts, bequests, offerings, contributions and money derived from the property of the corporation.

## VII

Two publications were made of notice of incorporation and election of directors (also known as trustees) of Community Bible Chapel of Route No. 2, Payette, Idaho. Said notices were placed in the Payette Independent-Enterprise, newspaper of general circulation for Payette, County of Payette, Idaho, on the twelfth day of September 1957, and on the nineteenth day of September 1957, two weeks prior to the scheduled meeting of its members, by said newspaper, the Payette Independent-Enterprise.

For two weeks prior to the meeting, a notice setting forth like information was posted in a conspicuous place on the building where election of directors and plans for organization were made.

Said meeting was duly held on Friday the 27th. day of September, 1957, with majority of members present, the Articles of Incorporation were read and adopted. Election of directors was effected. The following directors were elected.
