KNOW ALL MEN BY THESE PRESENTS, that at a special meeting of the shareholders and directors of Lewiston Roundup Association, Inc., an Idaho corporation, held at the office thereof in Lewiston, Idaho, at 7:00 o'clock P. M., on Wednesday, the 17<sup>th</sup> day of June, 1959, at which meeting all of the shareholders and directors of the corporation were present and which meeting was duly called and noticed, and consented to by all of the shareholders and directors of said corporation in writing, the following resolution was duly adopted by unanimous vote of all of the shareholders and directors of said corporation, to-wit:

RESOLVED that Article IV of the Articles of Incorporation of this corporation now reading as follows, to-wit:

"ARTICLE IV

That the term for which said corporation shall exist is twenty-five years from and after the date of its incorporation."
