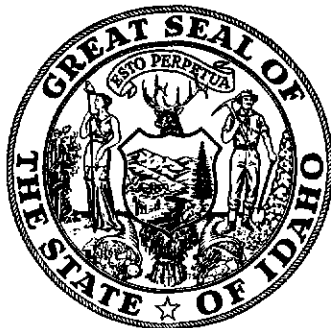
CERTIFICATE OF AMENDMENT OF

On March 18, 1993 at the annual stockholders' meeting, the stockholders voted to amend the ARTICLES OF INCORPORATION, ARTICLE V, of JEFFERSON HILLS GOLF & RECREATION CENTER, INC.


Two hundred-fifty shares were entitled to vote. One Hundred Fifty-five (155) voted. Eighty-nine (89) voted in favor of the amendment, sixty-six (66) voted against.

ARTICLES OF INCORPORATION, ARTICLE V amended as follows:

The capital stock of this corporation shall be increased by three hundred (300) shares, each with an equal vote, and with a par value of Three Thousand Dollars (\$3,000.00), increasing the existing authorized capital stock of the corporation from Five Hundred Thousand Dollars (\$500,000.00) with an additional Nine Hundred Thousand Dollars (\$900,000.00), making the total capital stock of the corporation One Million, Four Hundred Thousand Dollars (\$1,400,000.00). The said stock shall be limited to five shares (5) per shareholder.

In compliance with the By-Laws of Jefferson Hills Golf & Recreation Center, Inc., a State of Idaho registered corporation, and unless otherwise prohibited by law, the duly elected officers of Jefferson Hills Golf & Recreation Center, Inc., do hereby swear that the above amendment to the Articles of Incorporation was passed at the annual stockholders' meeting on March 18, 1993.
