ARTICLES OF INCORPORATION AND 29 PM '91 HEALTH ALTERNATIVES, INCORPORATED CRETARY OF STATE

ARTICLE I

Section 1. The name of this Corporation shall be HEALTH ALTERNATIVES, INCORPORATED.

ARTICLE II

The purposes for which the Corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act, including:

Section 1. Development and Promotion of Health Care Alternatives.

To develop and fund exploration of health care alternatives; to facilitate the availability of information allowing individuals to choose among all available resources and methodologies of health care; and, to promote public interest, education and support for the widest possible choices in health care from all disciplines and resources.

Section 2. Other Organizations, Entities or Individuals. To cooperate with other organizations, entities and individuals engaged in furthering the foregoing or similar objectives, including providing grants and all other types of assistance to such organizations, entities and individuals.

Section 3. Other Powers. In general, and subject to such limitations and conditions as are or may be prescribed by law, to exercise such other powers which may be necessary or incidental to the attainment of the purposes of the Corporation and to exercise all

rights and powers conferred on nonprofit corporations under the laws of Idaho, including the power to contract, rent, buy, or sell personal or real property, provided, however that this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this Corporation. The Corporation shall have the right and powers as may be exercised by an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1954 and its regulations, as they now exist or may hereafter be amended, and by an organization contributions to which are deductible under such regulations.

Section 4. <u>Political Activities</u>. No substantial part of the activities of this Corporation shall consist of carrying propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Section 5. <u>Dedication of Property</u>. The property of this Corporation is irrevocably dedicated to charitable purposes. In the event of the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to be used and dedicated as nearly as practicable in accordance with the purposes of this Corporation as set forth herein, to or for the benefit of organizations qualifying at the time of such distributions under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954 and its regulations, as they now exist or may hereafter be amended. Such assets may be disposed of in

such manner as may be directed by decree of the District Court in the county in which the Corporation has its principal office, upon petition therefor by the Attorney General or by any person concerned in the liquidation, in a proceeding to which the Attorney General is a party.

ARTICLE III

This Corporation is a nonprofit corporation and is not organized for the private gain of any person. It is organized pursuant to the Idaho Nonprofit Corporation Act for public and charitable purposes. No member of the Corporation shall derive any pecuniary gain or profit incidental or otherwise from the Corporation or the operation thereof except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article I above.

ARTICLE IV

The period of duration of the Corporation is perpetual.

ARTICLE V

The principal office for the transaction of the business of this Corporation is located in the County of Ada, State of Idaho.
