

KNOW ALL MEN BY THOSE PRESENT: that the undersigned citizens of the United States, desiring to form a corporation under the laws of the State of Idaho, declare:-

Ist. That the name of said Corporation shall be

2nd. The purpose for which this corporation is formed is to manufacture, compound and prepare for sale a composition and preparation known, called, and designated "Acme Egg Keeper", being a compound and preparation suitable to preserve eggs; to erect factories for the manufacture of said compound; to sell said compound, at wholesale and retail; to purchase the formula of said compound; to purchase the copyright entitled "Acme Egg Keeper"; to make and enter into contracts for the sale of said compound in any political subdivision of the United States, or any political subdivision of any State thereof .

3rd. The principal place of business to be transacted shall be the City of Boise, Idaho, and branch offices in Chicago, Illinois, and New York City, State of New York.

4th. The term for which this corporation shall exist shall be a period of (45) forty-five years.

5th. The number of directors shall be five persons, who shall be the stock holders of said Company.

6th. The amount of the capital stock of this corporation shall be One Hundred Thousand(\$100,000) Dollars, divided into 100,000 shares of the par value of One (\$1.00)Dollar each.

7th. The shares of this corporation shall be full paid and non-assessable.
