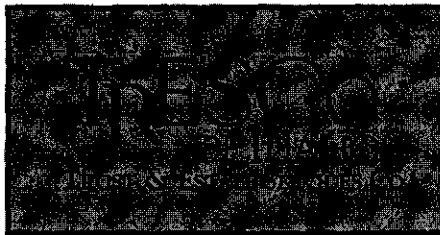

LETTERS OF CONSERVATORSHIP



Corporate Resolution of Authority
Trust and Estate Services Company (Tresco) of Idaho

I, **Paul Seideman**, an officer and secretary of the corporation, hereby certify the adoption of a resolution of authority as set forth below and which has been duly recorded in the minutes of the corporation:

Resolved that with any bank or investment company for whom those individuals or entities with a court ordered or contractual agency fiduciary relationship to Tresco of Idaho conduct depository, lending, or investment activities, that such funds may be withdrawn on receipts, checks, drafts or similar order signed in the corporate name by, or other written, verbal or electronic instruction of any of the following authorized persons:

Resolved Further that this authority shall extend to and include the authority of any one of the authorized persons to transfer or withdraw all or part of said funds, and to negotiate, endorse, and obtain payment or credit on orders or drafts payable on behalf of said fiduciaries. Authorized persons are empowered to act in all matters relating to inquiries of historical records of accounts, including transactions, copies of deposit and withdrawals slips, copies of checks, drafts, or other negotiable instruments, and statements.

Resolved Further that authorized persons are empowered to act on behalf of Tresco of Idaho to access, inventory, and remove all items held in safe-deposit boxes and to sign for such access on behalf of said fiduciaries.

Resolved Further that all prior resolutions relating to any of the above matters are hereby superseded and replaced by this authorization. This authority shall continue until notice in writing of its revocation shall be issued and bank or investment company has had reasonable opportunity to act on such notice.
