## ARTICLES OF INCORPORATION.

The name of the incorporation shall be and is THE BIG COTTON WOOD CANAL COMPANY.

The purpose for which this corporation is formed is to construct and maintain a canal from Big Wood River in Lincoln County, Idaho, to Little Wood River in said County, to convey of the unappropriated water of Big Wood River of the quantity of Two Hundred feet flow per second, to be used by the incorporators and stock holders of this corporation for irrigation along the valley of Little Wood River in Lincoln County, Idaho.
