#### ARTICLES OF INCORPORATION

OF

### SILVER SAGE GIRL SCOUT COUNCIL, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, duly authorized and empowered committee of the Silver Sage Girl Scout Council, an unincorporated association not organized for pecuniary profit and having a charter from Girl Scouts of the United States of America, do hereby associate ourselves for the purpose of forming a Membership Corporation pursuant to the provisions of the Membership Corporation of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

I.

The name of the corporation shall be "SILVER SAGE GIRL SCOUT COUNCIL, INC."

II.

The nature, objects and purposes for which this corporation is formed shall be:

- (a) To offer all girls, seven through seventeen, residing within its jurisdiction an opportunity to psrticipate in the Girl Scout program, in accordance with the purpose of the Girl Scout movement in the United States of America, which is to inspire girls with the highest ideal of character, conduct, patriotism, and service that they may become happy and resourceful citizens.
- (b) To develop, manage, and maintain Girl Scouting throughout the area of its jurisdiction, in such manner and subject to such limitations as prescribed in the Constitution, the By-Laws, and the policies of Girl Scouts of the United States of America and by the terms of the charter granted to the council by Girl Scouts of the United States of America.

(c) To hire, lease, buy, inherit, or otherwise acquire and hold land, buildings, equipment, or other real or personal property for a Girl Scout office, camp, or similar purpose; and to build, construct, operate, and manage the said property for the benefit of the Girl Scouts; to rent, lease, mortgage, or sell all or any part of such real or personal property acquired by said organization, as authorized by law.

- (d) To do, perform, and supervise any and all other things in furtherance of the general purposes hereinbefore expressed and not inconsistent with the Membership Corporation Laws of the State of Idaho; and to have and to exercise all the powers conferred by the laws of the State of Idaho upon corporation formed under the laws pursuant to and under which this corporation is formed as such laws are now in effect and may at anytime hereafter be enacted or amended.
- (e) To carry into effect the object and purposes aforesaid, this corporation is authorized to do all and singular the things necessary and conveneint to carry out the general purposes for which it is organized.
- (f) All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and digects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power or do any act which a corporation formed under the laws of the State of Idaho, now or hereafter existing may not, at the time, lawfully carry on or do. It is the intention that the purpose, objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any otherprovisions of these Articles of Incorporation.

#### III.

This corporation is nonsectarian, nonpolitical, and non-profitmaking. The rights and interests of all members shall be equal, and no member can have or acquire a greater interest herein than any other member. This corporation is organized under Chapter 10 of Title 30, Idaho Code, and is subject to all the provisions thereof.

IV.

The location and post office address of the registered office of the corporation is and shall be Boise, Ada County, Idaho.

This corporation shall have perpetual existence.

VI.

These Articles may be amended by a two-thirds vote of the members present and voting at any meeting of the corporation provided that the proposed amendment shall have been included in the notice of the meeting.

VII.
