CERTIFICATE OF INCORPORATION.

I, W.H.O. Morris, Secretary of State of the State of West Virginia,
do hereby certify that an agreement duly acknowledged and accompanied by
the proper affidavits, has been this day delivered to me, which agreement
is in the words and figures following:

I. The undersigned agree to become a corporation by the name of
SOUTHERN MOUNTAIN GOLD & SILVER MINING & MILLING COMPANY.

II. The principal place of business of said corporation shall be
located at 205 Fifth Avenue, Pittsburgh in the County of Allegheny, State
of Pennsylvania. Its chief works shall be located in the State of Idaho.

III. The object and purpose for which this corporation is formed
are as follows: the purchase, sale, operation and development of gold,
silver and other mineral properties within the State permitted by law,
and for the purchase and sale or leases pertaining thereto, and the
operating and development of the same; also the constructing, institution
and working of reduction works or mills for the reduction, milling and
smelting of mineral ores; for the construction and maintaining lines
of railroads, canals, water, gas, oil, gas, lighting, power, gas, steam,
or telegraph, telephone, lines of pipe for the transportation of water
and other fluids for use in carrying on the business properly pertaining
to such works and improvements; for the manufacture of metals and sale
of the same; for the carrying on of a general mercantile business, and
for any other purpose usual to the public for which a firm or partnership
may be lawfully formed in the State of West Virginia.

IV. The amount of the total authorized capital of said corporation
shall be Five million Dollars, which shall be divided into One million
shares of the par value of Five Dollars each, of which said authorized
capital the amount of One Hundred and Seventy Five Dollars has been paid.
