**ARTICLES OF INCORPORATION  
OF  
YELLOWSTONE GATEWAY , INC.**

**ONE:** The name of this corporation is Yellowstone Gateway , Inc.

**TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under Title 30, Chapter 3 Idaho Code and the Idaho Nonprofit Corporation Act for charitable purposes. The specific purposes for which this corporation is organized are to establish an educational institution for the purpose of instruction in, and dissemination of, educational material in the public interest including, but not limited to material relating to the fields of ecology, local history, natural history, spirituality and issues relating to the Greater Yellowstone Area in general, primarily through the publication of a monthly magazine *The Yellowstone Gateway Post* , but also through meetings, lectures, seminars, and other publications.

**THREE:** The name and address in the State of Idaho of this corporation's initial registered agent for service of process is Pat Feldsien, P.O. Box 324, Island Park, ID 83429.

**FOUR:**

(a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue

Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

**SIX:** The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any Director, officer or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation,

shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax-exempt status under Section 501 (c) (3) of the Internal Revenue Code.
