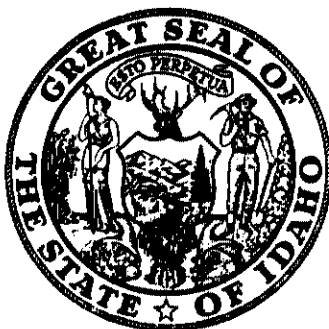
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is FRONTIER MOVING & STORAGE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is 568 Grange Lane, Twin Falls, Idaho 83301, and the name of its initial registered agent at such address is Tom Edmunds.

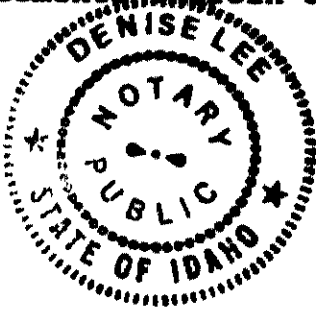
