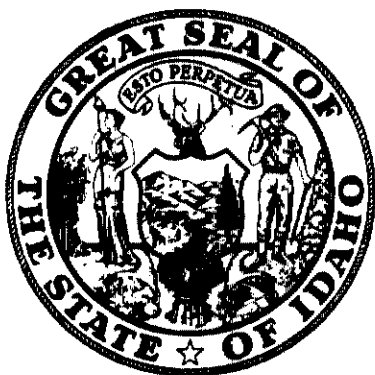

ARTICLE I  
GENERAL

Section 1: Name

This organization is incorporated under the laws of the State of Idaho and shall be known as the Grand View Chamber of Commerce Incorporated.

Section 2: Purpose

The Grand View Chamber of Commerce is organized to advance the general welfare and prosperity of the Grand View area so that its citizens and all the areas of its business community shall prosper. All necessary means of promotion shall be provided and particular attention and emphasis shall be given to the economic, civic, commercial, cultural, industrial and educational interest of the area.

Section 3: Area

The Grand View economic area shall be within Southern Owyhee County, the principle office to be located in the city of Grand View, State of Idaho.

Section 4: Limitations of Methods

The Grand View Chamber of Commerce shall observe all local, state and federal laws which apply to a non-profit organization as defined in Section 501 (c) (6) of the Internal Revenue Code.

Section 5: Seal

This Corporation may have a corporate seal which shall be a circular metallic seal containing between the outside and inside circles of the impression the words, "Grand View Chamber of Commerce, Inc. - Idaho."

Section 6: Duration

The Grand View Chamber of Commerce shall be organized for a duration of time which shall be perpetual.

ARTICLE II  
Board of Directors


Section 1: Composition of the Board

The Board of Directors shall be composed of five (5) members, one third of whom shall be elected annually to serve for three (3) years, or until their successors are elected and have qualified. The incoming President may appoint, subject to the approval of the Board from three (3) members to the Board to serve one-years terms. The past President and Vice-President shall serve as member of the Board.







The government and policy-making responsibility of the chamber shall be vested in the Board of Directors, which shall control its property, be responsible for its finances, and direct its affairs.


## Section 2: Indemnification
