### ARTICLES OF INCORPORATION

### KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, being natural persons of full age, and being citizens of the United States, and being desirous of associating ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and in pursuance of the laws thereof have agreed and do hereby certify as follows:

The name of this corporation shall be:

The purposes of this corporation and the pursuit or business which it is agreed shall be carried on by the corporation is the operation and conducting of a general farming and ranching business, including therein the propagation, growing, buying, selling and dealing in, garden, farm and agricultural products and commedities of every kind and nature, and the breeding, raising, production, buying, selling and otherwise dealing in domestic animals of every kind; to do each and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value of its property; to lease, buy, sell, use, mortgage, improve, or otherwise handle, deal in and dispose of all such property, real and personal, as may be necessary or convenient in connection with the aforesaid business of the company.
