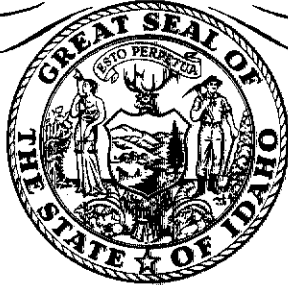

ARTICLES OF AMENDMENT
OF
ZIRBEL TRANSPORT, INC.

KNOW ALL MEN BY THESE PRESENTS: That Donald B. Zirbel, President, and Lucile Zirbel, Secretary, of the above named corporation, respectfully represent:

That the above named corporation was incorporated under the laws of the State of Idaho on the 31st day of May, 1957.

That on the 26th day of July, 1971, at a special meeting called for the purpose, and at which meeting all shareholders, officers and directors of ZIRBEL TRANSPORT, INC., an Idaho corporation, entitled to vote, were present, either in person or by a duly authorized proxy, the following resolution was duly moved and seconded:

BE IT RESOLVED that ARTICLE II(c) of the Articles of Incorporation of the corporation be amended, and that Articles of Amendment be prepared and submitted to the Secretary of State of the State of Idaho in accordance with this resolution, for approval by said office, whereby there shall be added unto the said Article II(c), as now constituted, the following paragraph:

The corporation may redeem issued and outstanding stock of the corporation, and in the event of any redemption of shares of stock, the legal title of such shares of stock, when acquired, shall vest in the company and shall thereafter be subject to control of the shareholders, who may make whatever disposition thereafter they deem fit upon vote of the majority of all remaining shares, and that for the purposes of redemption of its stock the company may use, apply and commit any available funds, including commitment of funds by way of future earnings.

BE IT FURTHER RESOLVED, that all other Articles of Incorporation and/or amendments be, and the same are hereby, ratified and approved.

That upon being put to a vote, the aforementioned resolution was passed unanimously, and all present, and entitled to vote, voting in the affirmative, and the President and Secretary were advised to issue their certificate to the Secretary of State of the State of Idaho for the purpose of amending the Articles of Incorporation in compliance with this resolution.

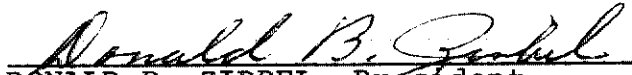

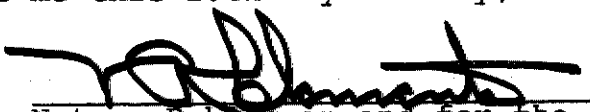
DONALD B. ZIRBEL and LUCILE ZIRBEL, being first duly sworn upon oath, each for himself and herself and not one for the other, deposes and says:
