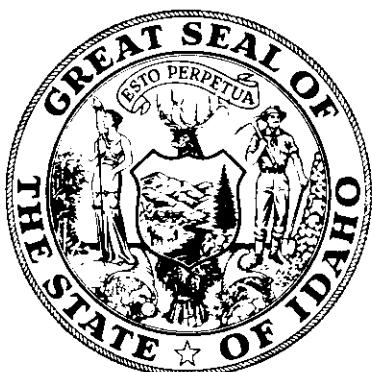

ARTICLES OF DISSOLUTION
OF
IDAHO PACKING CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, Thelma E. Stephens and Edward J. Berrett, the President and Acting Secretary, respectively, each being at least twenty-one years of age and residents of the State of Idaho, and all being citizens of the United States of American, in order to dissolve Idaho Packing Corporation for the purposes hereinafter stated, do, under and by virtue of the general laws of the State of Idaho auhtorizing the dissolution of corporations, associate ourselves as the President and Acting Secretary of Idaho Packing Corporation and do hereby certify as follows:
